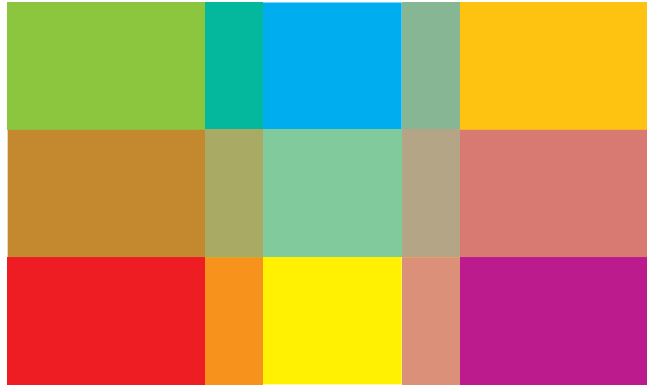

Dear library supporters,

In FY26, the Albany County Public Library Foundation contributed \$123,282 to your public library! This is \$20,000+ more than last year. Your willingness to support the ACPL Foundation is why we are able to continue strengthening your public library at a high level to provide a significant impact.

The ACPL Foundation Board of Directors and staff greatly appreciate our generous donors that ensure we can provide a \$60,000 annual disbursement to ACPL, as well as funding for other needs. In FY26, the \$60,000 disbursement supported all ages programming, materials, the bookmobile, technology, library supplies, building maintenance, travel for outreach and between branches, and continuing education.

Additional funding supported library outreach, special projects, designated purposes, and staff longevity. Beyond financial support, ACPL Foundation staff provided time (1,000+ hours) to library projects in FY26 by working on updates to the bookmobile, managing several projects, and hosting outreach events. For example, in FY26, the ACPL Foundation worked with three local artists in coordination with the construction project.

The majority of staff time for ACPL projects in FY26 provided project management support to the large-scale, ongoing infrastructure project. With this project coming to an end in 2026, the board will evaluate how the ACPL Foundation can continue to support the new spaces. With the time needed for this project coming to a close, our staff is excited to be able to debut a couple new events this year!

Here are a few FY26 highlights:

- Completed a 5-year strategic plan and developed a new mission statement and core values.
- For our core value of **Accessibility**: Met our fundraising goals because of you! This means ACPL can offer important resources and services to everyone in our community. The ACPL Foundation works to assist in removing barriers and addressing needs.
- For our core value of **Legacy**: Received \$332,502 in bequests or planned gifts from AMAZING donors to support ACPL in perpetuity.
- For our core value of **Bold Advocacy**: The ACPL Foundation advocates for your public library in our local community and around the state, especially during Legislative Session.
- For our core value of **Community**: Hosted a multi-purposes spaces grand opening, utilizing the ACPL Foundation Sally Dieterich Fund, as well as other outreach events and opportunities.
- For our core value of **Integrity**: Reviewed our policies and procedures; evaluated staff compensation, established organizational priorities, and set measurable goals.

In FY27, the ACPL Foundation plans to continue supporting ACPL with its entire programming budget, the bookmobile project, check out materials, technology, professional development for staff, building maintenance, library supplies and travel. 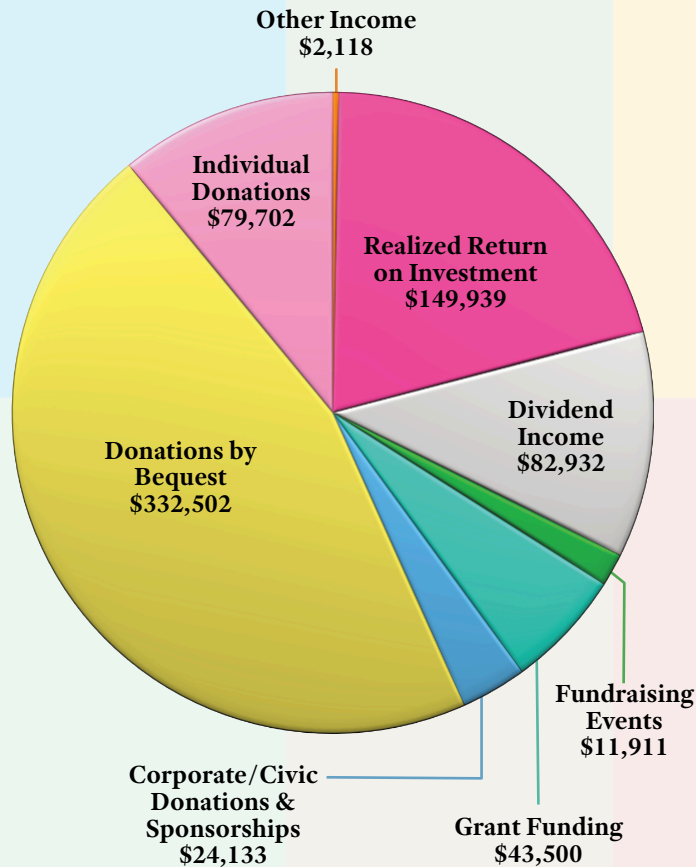

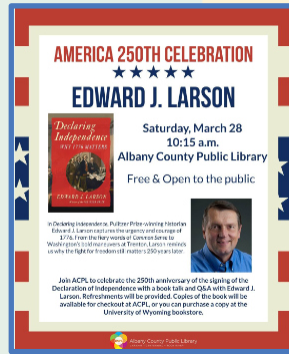

—**General Support:** The ACPL Foundation provided funding for essential library operations costs in FY26, such as building maintenance, library supplies, and travel between branches.

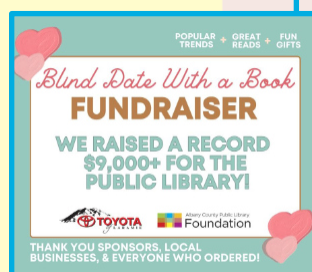

Contribute to an ACPL Foundation Restricted Fund:

Each restricted fund was created to benefit a specific purpose in the library. On a fiscal year basis, a portion of each fund provides the library with funding for specific programs or materials.

Colleen Asplund Fund: Asplund was a former ACPL children's librarian. Interest from this fund is used for children's materials.

John M. Burman Fund: Burman was the longtime chair of the ACPL Foundation board, served on the library board, and was a significant library supporter. The fund is used for general purposes.

Barbara Chatton Fund: Chatton is a longtime supporter and former ACPL Foundation board member. Interest from this fund goes to the library for its children and young adult collections.

Gwendolyn Cook Fund: Cook was a former head of library circulation. Interest from this fund is used to purchase cookbooks, romance, and mystery books.

Sally Dieterich Fund: Dieterich was a longtime library patron and supporter. The fund is used for library programming.

Friends of the Book Sale Fund: This fund is in honor of the work of the Friends of the Library Book Sale Crew. Interest from the fund is used to support the adult fiction collection.

Love Family Fund: J. David and Jane Love were longtime library supporters. This fund is used for the ACPL Foundation mini-grant program.

Neva Miller Fund: Miller was a former ACPL children's librarian. Interest from this fund is used for children's materials.

Adele Russin Fund: Russin was a longtime library supporter and former library board member. Interest and half of the fund's annual contributions benefit the library's adult Large Print books and audiobooks.
