# 2015–2016 Annual Report

The mission of the Albany County Public Library Foundation is to generate funds through gifts, endowments, memorials and special programs in order to improve the Albany County Public Library in perpetuity through specific programs, direct financial assistance and community outreach.



### Greetings,

As of June 30, 2016, the Foundation's total assets equaled \$1,915,574. Last year at this time, Foundation assets exceeded \$2 million. Unfortunately due to a downturn in the stock market, the Foundation portfolio saw losses. However, the Foundation has conservative controls on its assets to protect your donations, meaning we expect the portfolio to recover from this loss and return to \$2 million in total assets.

Even with the dip in the stock market, in fiscal year 2016 the Albany County Public Library Foundation still provided more than \$67,500 toward library materials, building maintenance, technology, all-ages programming, continuing education, designated purposes, and staff longevity bonuses. The Foundation assisted in funding numerous library employees' attendance at the Wyoming Library Association state conference and the Public Library Association national conference. Without funding from our donors, library staff would have been unable to learn new skills, network with other public library professionals, and return to your library with innovative ideas for the coming year.

Here are a few other accomplishments for the Foundation in FY16:

- Created and implemented the first annual "A Novel Night" murder mystery fundraiser (more details on p. 6).
- Held the Love Family Celebration in memory of J. David and Jane Love and their contributions to the Foundation.
- Sponsored the third annual End of Summer Reading Bash to celebrate literacy.
- Received \$12,000 in grant funding from the Union Pacific Foundation and the Wells Fargo Foundation.
- Completed a successful free income tax preparation program, filing 706 returns, for a total amount of federal and state refunds at \$840,159. Program attendees benefitted from more than \$270,000 in Earned Income Tax Credits.

Overall, FY16 was a positive year for the Foundation. Yet with the state's financial climate, the Foundation looks forward with a bit of apprehension. It is clear that in upcoming years Albany County will face additional cuts. These cuts will trickle down to the library, causing funding shortages. This will be a significant problem for the library as Albany County provides funding for many operational costs, most importantly for staff.

The Foundation Board of Directors wants to be able to contribute more to the library by increasing our annual fundraising. To do so, the board made the decision to have a fulltime executive director, as of Aug. 1, 2016.

In order to help the Foundation do more for the library, your support in FY17 is of grave importance. Please consider increasing your annual donation or becoming a monthly donor to help the Foundation meet the growing needs of the library. Your help is imperative in this library remaining a vibrant and valued part of our community.

Thank you for being a part of our library community and for your confidence in the Foundation's mission. It is because of you that the Foundation continues to make a positive impact on your library and we cannot thank you enough.





# **Contribute to an ACPL Foundation Restricted Fund:**

Each restricted fund was created to benefit a specific purpose in the library. Each year, a portion of each fund provides the library with funding for specific programs or materials.

**Colleen Asplund Fund:** Asplund was a former ACPL children's librarian. Interest from this fund will be used for children's materials in the library once the fund reaches \$10,000.

**Barbara Chatton Fund:** Chatton is a longtime supporter, volunteer, and Foundation board member. Interest from this fund goes to the library for its children and young adult collections.

**Gwendolyn Cook Fund:** Cook was a former head of library circulation. Interest from this fund is used to purchase cookbooks, Regency Romance, and mystery books for the library.

**Friends of the Booksale Fund:** Formerly the Penny Schenker Fund, this fund was set up to honor the work of the Friends of the Library Book Sale Crew. Interest from the fund is used to buy science fiction materials.

Love Family Fund: J. David and Jane Love were longtime library supporters. This fund is used for general library purposes.

**Neva Miller Fund:** Miller was a former ACPL children's librarian. Interest from this fund is used for children's materials in the library.

Agnes Milstead Fund: Milstead was a former library board member and library advocate. Interest from this fund is used for general library purposes.

Mary Lou Pence Fund: Interest from the fund supports the library's Wyoming Room. The Wyoming Room houses local and state historical documents, books and information.

**Adele Russin Fund:** Russin was a longtime library supporter and former board member. Interest and half of the fund's annual contributions benefit the library's Large Print books, audiobooks and Play-A-Ways.

**Susan Simpson Fund:** Simpson served as the ACPL county librarian and continues to support the public library. Interest from this fund is used for staff training and development opportunities.
